I know that participating in physical events such as bicycling tour/bicycle rental is a potentially hazardous activity. I agree not to participate unless I know how to bicycle, am medically able, have obtained my physician's approval (if applicable), am properly prepared and agree to wear a helmet.

On my own behalf and on behalf of any minors for whom I am registering, 1) I knowingly and freely assume full responsibility for my participation and all risks, both known and unknown, even if arising from the negligence of the releases or others, including but not limited to falls, contact with other persons or objects, the effects of weather, traffic and path conditions. I for myself, or any minors for whom I am acting waive and release Thousand Islands Bicycle Company- Tours and Rentals and any associated or related entities, their directors, employees, agents, and organizers ("Tour Organizers") from present and future claims and all liabilities of any kind, known or unknown, arising out of our participation in the tour or related activities. I agree that: (A) the Tour Organizers shall not be liable for any personal injury, death or property loss, and I release the Tour Organizers and waive all claims with respect thereto; and (B) to hold harmless and indemnify the Tour Organizers, from any and all liability for any property damage or personal injury to any third party resulting from our participation in the Tour.

2) I grant permission to Tour Organizers to use or authorize others to use any photographs, images or documentation of our participation in this Tour or related activities without remuneration being provided to us.

I represent and warrant that I am over eighteen (18) years of age, and that if I am registering a minor that I am the parent or guardian of such minor. I have read this waiver of liability and indemnity agreement. I understand and accept its terms.
